3. 研究分野 : 極限環境下となる宇宙等で利用される学際的な研究領域（例えば、核融合ロケット等の宇宙推進や原子力電池、ロボットなど）
4. 教育活動 : 大学院総合理工学府総合理工学専攻および工学部融合基礎工学科（高専連携プログラムを含む）の教育に従事する。また、九州大学基幹教育も担当することがある。
5. 応募資格 : 博士あるいは Ph. D.の学位を有すること。専門分野に業績があり、学部・大学院学生の教育や研究指導に意欲のある方。
6. 着任時期 : 採用決定後のできるだけ早い時期。
7. 勤務形態 : 常勤（任期なし）。

An open position of Associate Professor at Department of Advanced Energy Science and Engineering,

1. Position: One Faculty Member: Associate Professor
2. Faculty section: Department of Advanced Energy Science and Engineering, Faculty of Engineering Sciences (FES), Kyushu University.
3. Research field: Interdisciplinary research fields in the space under extreme environments, such as space propulsion, atomic batteries, and robotics.
4. Educational activities: The successful candidate will be required to lecture at IGSES for graduate students. In addition, the successful candidate will be required to lecture at School of Engineering and KIKAN education for undergraduate students. The candidate will also be required to supervise both Japanese and non-Japanese students in the bachelor, master and doctoral courses.
5. Required qualifications: A doctoral degree in any relevant science or engineering fields; a significant contribution to the candidate's research field; and firm willingness to education and research support for the bachelor, master and doctoral students.
6. Date of appointment: The earliest possible date after the hiring decision.
7. Term of employment: Regular full-time, Tenured (FES does not have a fixed-term contract system for faculty members.), Kyushu University has an age limit system for retirement (age limit for retirement of 65).
8. Work location: Faculty of Engineering Sciences, Kyushu University, which is located in Chikushi Campus: 6-1 Kasugakoen, Kasuga, Fukuoka 816-8580, Japan.
9. Compensation:
  - (1) Salary: the annual salary system, which was introduced on 1st April 2020, will be applied. The annual salary is determined under the university's pay scale based on experience.
  - (2) Working hours : based on Discretionary Labor System for professional work. Kyushu University allows the employee to engage in their work, while leaving it to their discretion to decide the means and the allotment of time for performing the work, and regarding them as having worked for the prescribed number of working hours (7 hours and 45 minutes).
  - (3) Days off : every Saturday and Sunday, national holidays, and other days as specified (e.g., New Year's holiday).
  - (4) The employee enrolls in : the health insurance, pension insurance, mutual retirement pension programs of Ministry of Education, Culture, Sports, Science and Technology, and employment insurance of Ministry of Health, Labour and Welfare.
10. Application documents: The following documents (1)–(9) must be prepared and submitted PDF files of the documents to the contact address. The upload address is informed to you after contact by e-mail.
  - (1) Curriculum vitae: a recent photograph, contact information (e-mail, etc.), educational records, professional records, and qualifications must be included.
  - (2) URL of the applicant's page of Google Scholar, total citation number, h-index, and i10-index.
  - (3) List of works: the applicant's research activities must be classified into the following five categories: i) Books; ii) Peer-reviewed first-author or corresponding author journal papers; iii) Peer-reviewed non-first-author journal papers; iv) Patents; v) Others. As for ii) and iii), the following information must be shown: all the authors' names listed in the order as printed in the article; article title; journal name; volume; pages; publication year.
  - (4) Statement on research experience, achievement and future research plan: no more than 3 pages

of A4 paper in length including figures/tables.

- (5) Statement on educational experience, achievement, motivation for the application to this position and policy for education: no more than 2 pages of A4 paper in length including figures/tables.
- (6) Activities at academic societies and social places: memberships, awards, and other significant activities must be listed.
- (7) List of obtained funds: JSPS/MEXT KAKENHI and other funds of joint research and contract research, in which the applicant is a principal investigator, must be listed.
- (8) Reprints of up to five representative papers. These representative papers should be marked in (3) List of works.
- (9) Two reference persons: name, title, affiliation, and contact information (phone and e-mail) must be shown.

11. Application deadline: All the submission documents must reach the following address by 12:00 JST, January 6, 2023.

12. Evaluation process: (1) Documents review,  
(2) Onsite or online Interview (only for candidates selected through the documents review process.)
